NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as lot No. 49 as shown on a plat of Nicholtown Heights No. 1, recorded in Plat Book F, at Page 68, as revised and recorded in Plat Book M, at Page 4, and being more particularly described according to said plat as follows:

\*\*BEGINNING at a point on the Eastern side of Mims Avenue (Formerly B Avenue) 80 feet North of the intersection of Mims Avenue and Taylor Street and which point is the joint front corner of lots Nos. 49 and 50, and running thence with joint line of said lots, N. 89-15 E. 110 feet to a point at rear corner of lot No. 66; thence with rear line of lot No. 66, N. 0-45 W. 40 feet to a point, joint rear corner of lots Nos. 48 and 49; thence with joint line of said lots, S. 89-15 W. 110 feet to a point on the East side of Mims Avenue; thence with said Avenue, S. 0-45 E. 40 feet to the point of beginning.\*\*
