Gempbell , in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor. In hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying about three miles northwest from the City of Green, and on the east side of the Old Rutherford Road (Road leading from Chicks Springs to Gilreath's Mill) being known and designated as Lots #'s 6,7,8,20,21, and 22 on a plat of property made for I. D. Bishop, by H. S. Brockman, Surveyor, dated July 20 1948, and having the following courses and distances to wit:
