All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Southeastern side of East North Street Extension (sometimes referred to as Spartanburg Road) in that area recently annexed to the City of Greenville in Greenville County, S. C. being shown as Lot No. 3 on Plat of College Heights, made by Dalton & Neves, Engineers, August 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book P, page 75, said lot fronting 75 feet along the Southeast side of East North Street Extension and running back to a depth of 200 feet on the Northeast side and running back to a depth of 200 feet on the Southwest side and being 75 feet across the rear.
