TO ALL WHOM THESE PRESENTS MAY CONCERN: **We, W.A. Christmas and Nettie**

J. Christmas

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Four Thousand
DOLLARS (\$ 4,000.00), with interest thereon from date at the rate of **six (6%)**

Township, on the West side of Pine Street and the North side of

recorded in the R.M.C. Office for Greenville County in Plat Book T
page 198 , and having a uniform width of 60 feet and a depth of 150
feet.
