the City of Greenville, Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot Number Seven (7) according to a map or plat of property of W.O.Groce as made in March, 1944 by R.E.Dalton, Engineer, which map or plat is of record in the R.M.C. office for said County and State in Plat Book "Q" at page 188, reference to which is hereby made; said lot of land being described by metes and bounds as follows, to wit:

Beginning at an iron pin on the Eastern side of Groce Avenue as shown on said plat, at the corner common to Lots 7 and 8 and running thence South 60-47 East, along the dividing line between Lots 7 and 8, One Hundred Forty-one and 6/10 feet to an iron pin on the rear line of Lot 17; thence North 36-57 East, along the dividing line between Lot 7 and Lots 17 and 18, Forty-one and 6/10 feet to an iron pin on the rear line of Lot 4; thence North 59-24 West, along the dividing line between Lot 7 and Lots 4, 5 and 6, One Hundred Forty-seven feet to an iron pin on the Eastern side of Groce Avenue; thence along the Eastern side of Groce Avenue, South 29-13 West Forty-five feet to the place of beginning.
