MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS I, E. M. PENDLETON _____ SEND GREETING:
 I, the said E. M. PENDLETON _____

_____ am indebted unto CAROLINA LIFE INSURANCE COMPANY, of Columbia, South Carolina, by my promissory note, in writing, of even date herewith, of which the following is a copy:

\$24,000.00 City of Greenville, South Carolina, March 16, 1950

"For value received, I _____ promise to pay to the order of CAROLINA LIFE INSURANCE COMPANY the principal sum of Twenty-Four Thousand (\$24,000.00) and No/100 _____ Dollars, with interest thereon from date hereof at the rate of $4\frac{1}{2}$ (%) per cent. per annum, said interest and principal sum to be paid in installments as follows:

"Beginning on the 16 day of April, 1950, and on the 16 day of each month thereafter, the sum of Two Hundred Sixteen (\$216.02) and 02/100 _____ Dollars, to be applied on the principal and interest of this note until the 16 day of March, 1962, when any balance remaining due on principal, with accrued interest, shall be payable in full. The aforesaid monthly payments of Two Hundred Sixteen (\$216.02) and 02/100 _____ Dollars each are to be applied first to interest at the rate of $4\frac{1}{2}$ (%) per cent. per annum on the principal sum of Twenty Four Thousand (\$24,000.00) and No/100 _____ Dollars, or so much thereof as shall from time to time remain unpaid, and the balance of each monthly payment shall be applied on account of principal; all installments of principal and interest of this note being payable at the Home Office of the CAROLINA LIFE INSURANCE COMPANY, at Columbia, South Carolina, in lawful money of the United States of America.

"This note and the interest are secured by a mortgage on real estate of even date herewith, duly recorded in the office of the ~~Register of Deeds~~ Register of Mense Conveyance _____ for Greenville County, South Carolina.

"If this note is placed in the hands of an attorney for collection, by suit or otherwise, or to enforce its collection, or to protect the security for its payment, I _____ will pay all costs of collection and litigation together with a ten (10%) per cent. attorney's fee.

"All installments of principal and interest of this note shall bear interest after the due date at the rate of six (6%) per cent. per annum.

"Upon failure to pay an installment of principal and interest of this note when due, then the remaining installments of interest and principal secured by said mortgage shall at once become due and payable, at the option of the legal holder hereof.

"The makers and endorsers severally waive demand, presentment, protest and notice of protest and expressly agree that this note, or any payment thereunder, may be extended from time to time without in any way affecting the liability of the makers and endorsers hereof."

"The payment of this note may be anticipated in whole or in part at any time, but a penalty of two (2%) per cent will be charged for such anticipatory payments made prior to three (3) years from date."
