To All Whom These Presents May Concern:

I, L. M. Miller,

SEND GREETING:

Whereas, I, the said L. M. Miller
in and by my certain promissory note in writing, of even date with these
presents, am well and truly indebted to B. S. Hodges

in the full and just sum of Two Thousand Five Hundred and No/100 (\$2,500.00) Dollars
to be paid on or before five years from date with principal
payment of \$30.00 payable monthly commencing April 28, 1950 and a like amount
on the 28th day of each and every month thereafter until paid in full.

, with interest thereon from date
at the rate of six per centum per annum, to be computed and paid quarterly in advance
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and
unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder
hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be
placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the
holder thereof necessary for the protection of his interests to place and the holder should place the said note
or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the
mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees,
this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

, in consideration of the said debt and
sum of money aforesaid, and for the better securing the payment thereof to the said B. S. Hodges
according to the terms of the said note, and also in
consideration of the further sum of Three Dollars, to me, the said L. M. Miller

, in hand well and truly paid by the said B. S. Hodges
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bar-
gained, sold and released and by the Presents do grant, bargain, sell and release unto the said B.S. Hodges,
All that piece, parcel or lot of land in Greenville County, State of South Carolina
in the City of Greenville, known and designated as a portion of Lot No. 14, Block "B"
of the O. P. Mills property, according to plat of same, recorded in the R.M.C. office
for Greenville County, South Carolina, in Plat Book "C" at Page 284 and have the
following metes and bounds:

Beginning at a stake on the West side of Elm Street, corner of Lot No. 15 and
running thence with line of said lot S. 45-27 W. 68.5 feet to stake in line of Lot
No. 13; thence along line of last mentioned lot S. 36-14 E. 50 feet to stake; thence
N.45-27 E. 68.5 to stake on Elm Street; thence with said Elm Street N. 36-14 W.
50 feet to the beginning corner.

Also, all that other certain parcel or strip of land adjoining the above described
lot, known and designated as a portion of Lot No. 15 of O. P. Mills property,
according to plat referred to above and described as follows:
