MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, C. B. Keenan, as Trustee (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Jas. L. Love, as Trustee for Jas. L. Love, Ben C. Thornton and Edgar C. Waldrop Estate (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Hundred and No/100- - - - DOLLARS (\$ 500.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: 90 days after date, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid quarterly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Selma Street, near the City of Greenville, and being shown as lot No. 29 on plat of property of Edgar C. Waldrop, made by Dalton & Neves in March 1946, and recorded in Plat Book B at Page 171, and described as follows:

"BEGINNING at a stake on the Eastern side of Selma Street, 275.7 feet South from Fair Street, at corner of lot No. 30 and running thence with the line of said lot, N. 86-06 E. 150 feet to a stake at corner of lot No. 21; thence with the line of said lot, S. 3-56 E. 50 feet to a stake at corner of lot No. 28; thence with the line of said lot, S. 86-04 W. 150 feet to a stake on Selma Street; thence with the Eastern side of Selma Street, N. 3-56 W. 50 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by the mortgagee by deed to be recorded.

It is understood and agreed that this mortgage is junior in lien to a mortgage this day executed by the mortgagor to Fidelity Federal Savings & Loan Association in the original amount of \$4000.00.
