all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, being known and designated as Lot No. 6, Block K of the O. P. Mills property, according to a survey made by R. E. Dalton, Engineer in May, 1914 and in November, 1914, plat of which is recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book C, at page 284, and Plat Book F, at page 171 and being more particularly described as follows:

Beginning at an iron pin on West Prentiss Avenue at the joint front corner of Lots Nos. 5 and 6 and running thence along the line of Lot No. 5 S. 44-33 E. 180 feet to an iron pin at the rear corner of Lot No. 6; thence S. 45-27 W. 62 feet to an iron pin at the joint rear corner of Lots Nos. 6 and 7; thence along the line of Lot No. 7 N. 44-33 W. 180 feet to an iron pin on West Prentiss Avenue; thence with West Prentiss Avenue N. 45-27 E. 62 feet to the point of beginning.
