"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal

Township, about one and one-half miles northwest from the City of Greer, lying on the South side of the New Greer-Oneal Road, bounded on the North by Miss Mamie Ballenger, on the East by lands of L.W. Jones, on the South by lands of C.F. Johnson, and on the West by lands of L.W. Jones, containing 8.89 acres, more or less, and being the identical property conveyed to me by L.W. M. Miller line; thence with the Miller line S. 37.00 E. 512.5 feet to the beginning corner.
