WHEREAS, the Mortgagor is well and truly indebted unto

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina:

All that piece, parcel or lot of land, with the improvements thereon,
situate, lying and being in or near the City of Greenville, Greenville County, South
Carolina, and being more particularly described as Lot **58** , Section **C** , as

made by Pickell & Pickell, Engineers, Greenville, S. C., January 14, 1950, and re-

No. **46** **East Seventh** Street (Avenue) and fronts thereon **66** feet.

said premises.

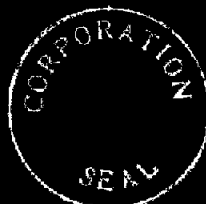
*The Mortgagor covenants and agrees that so long as this mortgage and
