All that certain piece, parcel or lot of land with the buildings and improvements thereon situate and being on the Northwest side of Langley Drive in that area recently annexed to the City of Greenville, in Greenville County, S. C. being shown as Lot No. 28 and the Northeast one-half of Lot 27 adjacent thereto on Plat of Langley Heights, made by Dalton & Neves, Engineers, June 1937, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "I", at pages 142-143, said lot fronting 75 feet on the Northwest side of Langley Drive and running back to a depth of 199.8 feet on the Northeast side, a depth of 184.05 feet on the Southwest side and being 76.65 feet across the rear along a 15 foot alley.
