"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, known and designated as lot No. 7, Block H, as shown on plat of Highland Terrace, Hindman Development, dated October 1936, recorded in plat book "K" at pages 120-121 of the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the west side of Townes Street Extension which point is the joint front corner of lots 6 and 7, and running thence with the joint line of said lots N. 73-16 W. 150 feet to the joint rear corner of said lots; thence S. 16-44 W. 50 feet to the rear corner of lot No. 8; thence with the line of said lot S. 73-16 E. 150 feet to a point on the west side of Townes Street Extension, the front joint corner of lots 7 and 8; thence with the west side of said Townes Street Extension N. 16-44 E. 50 feet to the beginning corner, this being the same lot conveyed to the mortgagor by Lucy L.
