MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, D. E. Woodward (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto O.Y. Brownlee and O.Y. Brownlee, Jr.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifty-Seven Hundred Fifty & No/100

DOLLARS (\$5750.00),

with interest thereon from ~~date~~ ^{maturity} at the rate of Six per centum per annum, said principal ~~and interest~~ to be repaid: 90 days after date, with interest thereon from maturity at the rate of Six per cent, per annum, to be computed and paid quarterly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Ashley Avenue, in the City of Greenville, and being a portion of lots Nos. 1 and 2 of Block F as shown on plat of Buist Circle, recorded in Plat Book C at Page 10, and described as follows:

"BEGINNING at a stake on the Northern side of Ashley Avenue, 90 feet East from Townes Street, and running thence N. 8-36 E. 104 feet to a stake; thence S. 83-01 E. 60 feet to a stake; thence S. 9-59 W. 123 feet to a stake on Ashley Avenue; thence with the northern side of Ashley Avenue, N. 64-25 W. 60 feet to the beginning corner, and being the same property conveyed to the mortgagor by Melta E. Dill by deed dated August 22, 1947, recorded in Book of Deeds 318 at Page 401."
