M. C. office for Greenville County in Plat Book "V", at page 30, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of U. S. Highway No. 29 at corner of now or formerly property of Kohn, and running thence with his line, S. 74-02 E. 666 feet to an iron pin; thence S. 22 W. 105.6 feet to an iron pin and corner of other property of H. H. Williams; thence with the Williams line, N. 74-02 W. 627 feet to an iron pin on the eastern side of U. S. Highway 29; thence with said highway, N. 16-20 E. 100 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
