"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being known and designated as a portion of the eastern half of Tract 31 as shown on plat of Riverside Farms recorded in Plat Book K at Pages 100-103, and being more particularly described as follows:

"BEGINNING at an iron pin on the Northern side of a 30 foot street, now known as Edgement Avenue, at the joint front corner of tracts 31 and 32, and running thence with the joint line of said tracts in a Northeasterly direction 150 feet to an iron pin; thence in a Northwesterly direction parallel with Edgement Avenue, 100 feet to an iron pin; thence in a Southwesterly direction parallel with the joint line of tracts 31 and 32, 150 feet to an iron pin in the Northern side of Edgement Avenue; thence with said Avenue, in a Southeasterly direction 100 feet to the point of beginning."
