All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the Morth side of Potomac Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot 189, on Plat of Pleasant Valley, made by Balton & Neves, Angineers, April 1346, revised through November 1948, recorded in the R. M. C. Office for Greenville County, S.
