I, Eleanor Giles Stover

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand and No/100- - - - -  
DOLLARS (\$ 4000.00 ), with interest thereon from date at the rate of Six (6%) - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Gallivan Avenue, in the City of Greenville, and being shown as lot No. 52 on plat of North Hills made by R.E. Dalton in April 1925, recorded in Plat Book H at Page 138, and described as follows:

"BEGINNING at a stake on the Southern side of Gallivan Avenue at corner of lot No. 51 and running thence with the line of said lot, S. 19-17 W. 151 feet to a stake; thence in a westerly direction 50.7 feet to a stake; thence N. 12-37 E. 149.7 feet to a stake on Gallivan Avenue; thence with the Southern side of Gallivan Avenue, S. 71-43 E. 69 feet to the beginning corner, and being one of the lots conveyed to the mortgagor by Central Realty Corporation by deed dated September 2, 1948, recorded in Book of Deeds 361 at Page 153."
