To All Whom These Presents May Concern:

I, R. C. Gray, of Greenville County, South Carolina, SEND GREETING:

Whereas, I, the said R. C. Gray,

in and by my certain promissory note in writing, of even date with these

Presents, am well and truly indebted to Oscar Hodges, Jr., and Sarah S. Hodges,

in the full and just sum of THREE HUNDRED and no/100 (\$300.00) DOLLARS,

to be paid One (1) year after date,

with interest thereon from date

at the rate of Six per centum per annum, to be computed and paid annually

until paid in full: all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said Oscar Hodges, Jr.,

and Sarah S. Hodges, their heirs and assigns,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near northern limits of the City of Greenville, near to and north of old Camp Road, on northern side of Scott Street, and being shown and designated as Lot Number Three (No. 3) on a plat of the property of Walter F. Alewine, made by H. S. Brockman, Sur., July 22, 1946, recorded in Plat Book "B" at page 190 in the R. M. C. office for Greenville County, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a point on northern side of Scott Street, joint corner with Lot No. 2 of said plat, and running thence N. 22-15 W. 128.8 feet along the western line of said Lot No. 2, to point, joint corner with Lot No. 2, on southern side of a 16-foot alley; thence S. 71-15 W. 28.1 feet along southern side of said alley to a point on eastern side of a 16-foot alley leading from Scott Street, northward; thence S. 18-52 E. 129 feet along the eastern side of the said last mentioned alley to a point at its intersection with northern side of Scott Street; thence N. 70-50 E. 36 feet along northern side of Scott Street to the point of beginning.
