organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of SEVEN THOUSAND NINE HUNDRED Dollars (\$ 7.900.00 ), with interest from date at the rate of

per centum ( 4%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty-Seven and Eighty-Eight One-Hundredths Dollars (\$47.88), commencing on the first day of September, 1950, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 1970.

Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, 'State of South Carolina;

All that certain piece, parcel or lot of land on the Eastern side of Brockwood Drive, in the City of Greenville, South Carolina, in a Subdivision known as Stone Estates, being known and designated as Lots Nos. 12 and 13, Block F of said Subdivision and being described according to a plat of Stone Estates recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book G, at Page 292, and according to a more recent plat prepared by Piedmont Engineering Service, Greenville, South Carolina, dated July 14, 1950, entitled "Property of William Harley Russell, Greenville, S. C.", and having according to said plats the following metes and bounds, courses and distances:

BEGINNING at an iron pin on the Eastern side of Brookwood Drive at the joint front corner of Lots Nos. 13 and 14, Block F, which iron pin is 500 feet from the intersection of Brookwood Drive and Reid Street, and running thence along the common line of Lots 13 and 14, S. 78-38 E. 160.3 feet to an iron pin; thence S. 9-30 W. 50 feet to an iron pin, the joint rear corner of Lots 11 and 12, Block F; thence along the common line of said last mentioned Lots, N. 78-38 W. 161.1 feet to an iron pin on the Eastern side of Brookwood Drive; thence along the Eastern side of Brookwood Drive, N. 11-22 E. 50 feet to an iron pin, the beginning corner.

Also included as part of the mortgaged premises are the following easily removable real estate items: Drace 72,000 BTU Oil floor furnace with 275 gal. tank, Mission 30 Gal. Electric Water Heater, and Disappearing stairway.

The mortgagor covenants that until the mortgage has been paid in full he will not execute or file for record any instrument which imposes a restriction upon the sale or the occupancy of the mortgaged property, on the basis of race, color, or creed. This covenant shall be binding upon the mortgagor and his assigns and upon the violation thereof, the mortgagee may, at its option, declare the unpaid balance of the mortgage immediately due and rayable.
