Greenville Home Builders, Inc. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto H. C. Smith and C. S. Fox (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand and No/100- - -

DOLLARS (\$ 1000.00),

with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid: on or before January 13, 1951, with interest thereon from date at the rate of Five (5%) per cent, per annum, to be computed and paid semi-annually.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

That ~~the~~ ~~same~~ ~~piece~~ ~~parcel~~ ~~or~~ ~~lot~~ of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Frontus Street, in the City of Greenville, and being shown as lot No. 55 on plat of Rockwood Park, made by Pickell & Pickell on August 24, 1948, revised on October 5, 1948, and recorded in Plat Book S at Pages 168 and 169, and described as follows:

"BEGINNING at a stake on the Western side of Frontus Street, at corner of lot No. 54, and running thence with the line of said lot, N. 81-49 W. 175 feet to a stake; thence S. 8-11 W. 75 feet to a stake at corner of lot No. 56; thence with the line of said lot, S. 81-49 E. 175 feet to a stake on Frontus Street; thence with the Western side of Frontus Street, N. 8-11 E. 75 feet to the beginning corner."
