with interest thereon from date

at the rate of 7 per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
 the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
 may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
 hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
 necessary for the protection of his interests to place and the holder should place the said note or this mortgage

 Township of Greenville County, South Carolina, lying on the West
 side of Albert Street, having the following courses and distances:
 BEGINNING at a stake on Albert Street, and runs thence with said
 street S. 9.30 E. 60 feet; thence S. 80.30 W. 185.4 feet to a stake;
 thence N. 0.14 W. 60.8 feet to a stake; thence N. 80.30 E. 175.8
 feet to the beginning corner, and being all of lot No. 20 on a plat
 of the Marchant Place, as shown by record thereof in the R.M.C.
 Office for Greenville County.
