I, B. D. Quinn

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100- - - - - DOLLARS (\$3000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, fronting 50 feet on the Eastern side of Third Avenue, with a depth of 150 feet, being known and designated as lot No. 8 of Block J as shown on plat of Park Place Addition, recorded in the R.M.C. Office for Greenville County in Plat Book A at Page 219, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin at joint corner of lots Nos. 6 and 8, and running thence N. 89-45 E. 150 feet to an iron pin in a 10-foot alley; thence with said alley, N. 0-17 E. 50 feet to an iron pin, corner of lot No. 10; thence with the line of said lot, S. 89-45 W. 150 feet to an iron pin on Third Avenue; thence with Third Avenue, S. 0-17 W. 50 feet to the beginning; said premises being the same conveyed to the mortgagor by deed of J.W. Quinn dated February 26, 1940, recorded in Plat Book 218 at Page 365."
