until paid; interest to be computed and paid monthly and if unpaid when due to

being in Gantt Township, Greenville County, State of South Carolina,
in Conestee Mill Village and being known and designated as Lot #57 as
shown on a plat entitled "Map of Conestee, S. C.", recorded in the
R. M. C. Office for Greenville County, S. C. in Plat Book "K", Page
276, and having according to said plat the following metes and bounds,
to-wit:

BEGINNING at a point on the Southeast side of Second Street, joint
front corner of Lots 56 and 57, and running thence along the joint line
of Lots 56 and 57, S. 48-22 E. 257 feet to a point, joint corner of
Lots 71, 72, 56 and 57; thence along the line of Lots 71 and 70, S. 42-
