TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, JAMES E. JOHNSON, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Hundred and no/100 DOLLARS (\$ 500.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township and being shown as Lot 31 on plat recorded in Plat Book "H" at page 117, being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin in Columbus Avenue where it turns almost at right angles and the Northeast side of said Avenue; and running thence N. 44-13 E. 48 feet; thence S. 45-47 E. 122 feet; thence S. 40-15 W. 73.7 feet to Columbus Avenue; thence along said Avenue N. 32-25 W. 129.6 feet to point of beginning.

Said premises being the same as those conveyed to Mortgagor by deed recorded in Deed Book 203, page 111.
