"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler. Township, School District 7-H, containing 16.5 acres, more or less, and being known and designated as Tract No. 6 of a subdivision of the C. R. Bramlett Farm as shown on plat thereof prepared by W. J. Riddle, Surveyor in March, 1937, and having, according to the above plat and a resurvey prepared in May, 1941, the following metes and bounds, to-wit:

"BEGINNING at a point in the center of the road leading to the municipal airport at the intersection of a new road, which point is also the corner of Tract No. 5, and is in the line of the J. H. Southern land, and running thence along the southeast side of the Airport Road, N. 67 E. 403 feet, more or less, to an iron pin at the corner of Tract No. 7 of the Bramlett Farm; thence along the line of that tract, S. 29-30 E. 1,459 feet, more or less, to an iron pin at the rear corner of said tract; thence S. 33-00 W. 575 feet to a stake in the center of said road and in the line of the property of J.
