"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, In Greenville Township, on the Southeastern side of Tremont Avenue, near the City of Greenville, being shown as Lot No. 9 of Block "H" on plat of Melrose Land Company recorded in Plat Book "A" at page 157 and described as follows:
