TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, S. L. Robertson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto South Carolina National Bank of Greenville, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand and No/100- - -

DOLLARS (\$3,000.00),

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: Six months after date; with the privilege to anticipate.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 6 of Block B according to Plat of Fair Heights Subdivision, as shown on Plat on record in RMC Office for Greenville County in Plat Book F at Page 257, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on NW/s of Dakota Avenue at the joint front corners of Lots Nos. 5 and 6, and running thence along the line of Lot No. 5, N. 58-40 W. 150 feet to an iron pin at the joint rear corners of Lots Nos. 5 and 6; thence along the rear line of Lot No. 6, S. 31-20 W. 50 feet to an iron pin at the joint rear corners of Lots Nos. 6 and 7; thence along the line of Lot No. 7, S. 58-40 E. 150 feet to an iron pin on Dakota Avenue; thence along Dakota Avenue, N. 31-30 E. 50 feet to the point of beginning."
