TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, HARRY W. WEEKS, JR., (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and no/100 ----- DOLLARS (\$ 10,000.00), with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the Southeastern side of McPherson Lane, being known and designated as Lot No. 23 of the Goddard-McPherson property and having, according to a plat thereof dated May 11, 1938 and not recorded, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of McPherson Lane, at joint front corner of Lots 21 and 23, and running thence along the joint line of said lots S. 41-27 E. 237.7 feet to an iron pin at rear line of Lot 29; thence along rear line of Lot 29, N. 55-55E. 128.8 feet to an iron pin at joint rear corner of Lots 23 and 25; thence along the joint line of said lots, N. 52-07 W. 258 feet to point in line of McPherson Lane; thence along the Southeastern side of McPherson Lane, S. 48-47 W. 80 feet to the point of beginning, being the same premises conveyed to the mortgagor by deed recorded in Book 409 at page 104.
