To All Whom These Presents May Concern:

Sunie F. Ferguson and Mary Alice Ferguson Wood SEND GREETING:

Whereas, we, the said Sunie F. Ferguson and Mary Alice Ferguson Wood, in and by our certain promissory note in writing, of even date with these Presents, are well and truly indebted to Sarah L. Campell

in the full and just sum of Eight Thousand, Five Hundred and no/100 (\$8,500.00), to be paid Three Hundred (\$300.00) Dollars six (6) months after date and Eight Thousand, Two Hundred (\$8,200.00) Dollars one year after date;

, with interest thereon from date at the rate of five per centum per annum, to be computed and paid quarterly until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, situate at the intersection of Rhett and Wardlaw Streets, and running along the East side of Rhett Street N. 71-30 E. 43 feet to a stake, a new corner; thence a new line S. 18-30 E. 150 feet to a stake, a new street; thence S. 71-30 W. 43 feet to Wardlaw Street; thence with said street N. 18-30 W. 150 feet to the beginning corner.
