I, Edna Jones Christopher (hereinafter referred to as Mortgagor) SEND(S) GREETING:  
(formerly Edna P. Jones)

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty Three Hundred and no/100 - - - - - DOLLARS (\$ 2300.00 ), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Ladson Street in the City of Greenville being shown and designated as Lot 24 on plat of the property of O. P. Mills recorded in Plat Book "C" at page 294 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stake on the Western side of Ladson Street 220 feet South from the intersection of Ladson and Otis Avenue at the corner of Lot 25 and running thence with the line of Lot 25 S. 54-28 W. 186.2 feet to a stake in line of Lot 8; thence with the line of Lots 8 and 9 S. 36-50 E. 50 feet to an iron pin at the rear corner of Lot 23; thence with the line of Lot 23 N. 54-28 E. 185.1 feet to a stake on Ladson Street; thence with the Western side of said street N. 35-32 W. 50 feet to the point of beginning; being the same premises conveyed to the mortgagor under the name of Edna P.
