"BEGINNING at an iron pin on the northeast side of the Laurens Road, joint front corner of Lots Nos. 213 and 214, said pin being 260 feet in a southeasterly direction from the intersection of Laurens Road with Sycamore Drive, and running thence with the line of Lot No. 214, N. 22-56 E. 217.4 feet to an iron pin in the line of Lot No. 209; thence along the line of Lot No. 209. S. 68-28 E. 46 feet to an iron pin in the line of Lot No. 212; thence with the line of Lot No. 212, \$. 20-24 W. 239.4 feet to an iron pin on the northeast side of the Laurens Road; thence with the northeast side of the Laurens Road, N. 46-53 W. 60 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot

of land conveyed to us by J. H. Mauldin by deed of even date herewith, not yet recorded
