"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, lying on the South side of the Mt. Lebanon Road, a road that leads from the Jordan Road by Mt. Lebanon Baptist Church to Gramling, and lying on the opposite side of the road from the Mt. Lebanon School, bounded on the North by said school and on all other sides by W.P. Sloan, said lot having situate thereon a five-room frame dwelling, having the following courses and distances: BEGINNING on an iron pin in the center of the Mt. Lebanon Road, the northeastern corner of the lot, and runs thence in a southernly direction 210 feet to an iron pin; thence in a westernly direction 210 feet to an iron pin; thence in a northernly direction 210 feet to an iron pin; inethe center of the Mt.
