All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Northwest side of Cammer Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as Lot 17 on plat of Property of G. F. Cammer, made by R. E. Dalton, Engineer, February 1923, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "L", at page 115, and having, according to said plat and a recent survey made by R. W. Dalton, Surveyor, December 11, 1950, the following metes and bounds, to-wit:
