Greenville Township, Greenville County, State of South Carolina,  
on the Eastern side of Bridwell Avenue, near the City of Greenville, being  
shown as Lots 88 and 89 on plat of Nicholtown Heights made by C. M. Furman,  
Jr. on June 7, 1922, revised by W. J. Riddle, in March 1941 and recorded  
in Plat Book "M", at page 4, described as follows:

BEGINNING at a stake on the Eastern side of Bridwell Avenue 80 feet North  
from Taylor Street at corner of Lot 90 and running thence with the line  
of said lot, North 89-15 East 110 feet to a stake in line of Lot 104;
