State of South Carolina; All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the South side of Potomac Avenue, in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 230, on plat of Pleasant Valley, made by Dalton & Neves, Engineers, April 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "P", at pages 92 and 93, said lot fronting 60 feet along the South side of Potomac Avenue, and running back to a depth of 160 feet on the East side, to a depth of 160 feet on the West side, and being 60 feet across the rear.
