WHEREAS,the said Local Horne Builders. Inc., a corporation organized and
existing under the laws of the State of South Carolina
in and byitscertain promissory note, in writing, of even date with these presentsiswell and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full
and just sum ofF.ive. Thousand. Five. Hundred. and. No/100 (\$. 5,500.00)
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

"BEGINNING at an iron pin on the southwest side of Poplar Street at the corner of Lot No. 5, which point is 315 feet southeast of the intersection of McBee Boulevard, and running thence along the line of Lot No. 5, S. 49-40 W. 160 feet to an iron pin at the rear corner of said lot in the rear line of Lot No. 13; thence along the rear line of Lots Nos. 13 and 12, S. 40-20 E. 63 feet to an iron pin at the rear corner of Lot No. 7 in the rear line of Lot No. 12; thence along the line of Lot No. 7, N. 49-40 E. 160 feet to an iron pin at the corner of said lot on the southwest side of Poplar Street; thence along the southwest side of Poplar Street, N. 40-20 W. 63 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed therein, which are hereby expressly agreed to be a part of the realty.
