TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. A. Chandler, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Hundred and No/100- - - - - DOLLARS (\$ 1200.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Southern side of East McBee Avenue, in the City of Greenville, being shown as Lot No. 5, Section 2, Page 64 of the City Block Book, and described as follows :

"BEGINNING at an iron pin on the East McBee Avenue, at the corner of lot now or formerly owned by Ted Edwards, and running thence along the line of said lot in a Southwesterly direction 128 feet to iron pin on Poole Street; thence with the northern side of Poole Street in an easterly direction 75 feet, more or less, to iron pin; thence with the line of said lot in a northeasterly direction 128 feet to iron pin on East McBee Avenue; thence with the southern side of East McBee Avenue in a westerly direction 72.3 feet to the point of beginning."

Said premises being the same conveyed to the mortgagor by Margaret W. Riley et al by deed recorded in Book of Deeds 262 at Page 283.
