(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Twelve Hundred Twenty-five

DOLLARS (\$ 1,225.00), with interest thereon from date at the rate of **Six** per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, lying on the East side of Piedmont Avenue, designated as Lot No. 20 on a plat of property known as "Morrow Heights" made for R.D. Dobson Estate by H.S. Brockman, Surveyor, dated Sept., 1935, recorded in the R.M.C. Office for Greenville County in Plat Book I, page 120, and having the following courses and distances: BEGINNING at a stake on the East side of Piedmont Avenue, corner of Lot No. 19, and runs thence S. 77.49 E. 150 feet to a stake, corner of Lots Nos. 30 and 31; thence S. 11.47 W. 100 feet to a stake, corner of Lot No. 21; thence N. 77.49 W. 150 feet to a stake on the East side of Piedmont Avenue; thence therewith N. 11.47 E. 100 feet to the beginning corner, and being the same property conveyed to us as appears by reference to record of deed in Deed Book 349, at page 377 in the R.M.C. Office for Greenville County, and includes herewith the right to the water line set forth in said deed.

Together will all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
