TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Johnnie W. Murrell (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - - DOLLARS (\$ 5,000.00 ), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Northern side of Mills Avenue Extension, being shown as Lot No. 9 on Plat of Property of S. H. Earle, made by Pickell and Pickell on February 26, 1951, recorded in Plat Book Z at Page 191, and described as follows:

"BEGINNING at a stake on the Northern side of Mills Avenue Extension at the corner of Lot No. 10, and running thence with the line of said lot, N. 17-52 W. 195.5 feet to a stake at corner of Lot No. 17; thence with the line of said lot, N. 48-53 E. 76.2 feet to a stake at corner of Lot No. 8; thence with the line of said lot, S. 17-52 E. 225.6 feet to a stake on Mills Avenue Extension; thence with said Mills Avenue Extension, S. 72-08 W. 70 feet to the beginning corner."
