"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, lying southeast of the Rutherford Road and at the intersection of Welter Lane and an unnamed street, and being known and designated as lot 42 as shown on a plat of Rutherford Park, property of L. A. Mills, made by Dalton & Neves, Engineers, September 30, 1946, and having according to said plat the following metes and bounds:

"BEGINNING at an iron pin in the Northwestern side of Welter Lane, the joint corner of lots 42 and 43, and running thence with the joint line of said lots, N. 54-30 W. 184.6 feet to an iron pin; thence S. 86-50 E. 169.9 feet to an iron pin in the west side of an unnamed Street; thence along the west side of said unnamed street, S. 0-30 E. 70 feet to an iron pin at the intersection of said unnamed street, and Welter Lane; thence with the Northwestern side of Welter Lane, S. 35-30 W. 34 feet to the beginning Corner."
