And the said assettingor(s) agree(s) to insure and keep insured the houses and buildings on said lot in a sum not less than Five Thousand and No/100(\$5,000.00) - - - Dollars in a company or companies satisfactory to the mertgagee(s) from loss or damage by fire, with extended coverage endorsement thereon, and assign and deliver the policies of insurance to the said mortgagee(s) and that in the event the mortgager(s) shall at any time fail to do so, then the mortgagee(s) may cause the same to be insured and reimburse itself for the premium, with interest, under this mortgage; or the mortgagee(s) at its election may on such failure declare the debt due and institute foreclosure proceedings.
