All that piece, parcel or tract of land in Butler Township, Greenville County, State of South Carolina, near the Municipal Airport. and being a portion of the Joe Poole place, containing Three and 44/100 (3.44) acres, more or less, and, according to a survey made by M. H. Woodward, R. E., on June 20, 1946, having the following metes and bounds. to-wit:

BEGINNING at a point in line of the M. F.
