(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Dakota Avenue (Formerly Parkins Mill Road) and having according to a plat made by Dalton & Neves, May 1951, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Western side of Dakota Avenue, at the joint front corner of Adams and Wingo properties, and running thence with the Western side of Dakota Avenue, S. 33-55 W. 220 feet to an iron pin in line of other property of Wingo; thence with line of said property, N. 56-05 W. 410 feet to an iron pin; thence continuing with other property of Wingo, N. 33-55 E. 201 feet to an iron pin, corner of property of Adams; thence with line of said property, S. 58-45 E. 410.4 feet to the point of beginning.
