TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, E. S. McCallum

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100- - - - -

DOLLARS (\$ 6000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the Northwestern side of U.S. Highway No. 29, near Grove Station, being lots 5, 6, 7, 8 and 9 and the lot designated "O.C. Vest and Lula Jane Vest", on plat of Grove Station Heights, made by Piedmont Engineering Service, May 18, 1948, and described as follows:

"BEGINNING at a stake at the Northern corner of U.S. Highway No. 29, and a County Road and running thence with the Eastern side of said Road, N. 19-06 W. 570 feet more or less to a stake on Moody Street; thence with the Southern side of Moody Street, N. 78-31 E. 151 feet to a stake at corner of lot 4; thence with the line of said lot, S. 19-06 E. 195 feet to a stake at corner of lot 9; thence continuing with the lines of lots 4 and 3, N. 78-31 E. 85.2 feet to a stake at corner of lot 1; thence with the line of said lot, S. 39-55 E. 197.3 feet to a stake on U.S. Highway No. 29; thence with the Northwestern side of said Highway, S. 43-58 W. 342.9 feet more or less to the beginning corner."
