TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, J. W. Cannon & J. E. Meadors, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-five Hundred and No/100- - - - - DOLLARS (\$ 8500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Eastern side of Broughton Drive, in a subdivision known as Croftstone acres, being known and designated as Lot No. 48, Section H of a revised portion of Croftstone Acres, and being described according to a Plat of said partial revision of Croftstone acres recorded in the R. M. C. Office for Greenville County in Plat Book T at Page 311 as follows:

"BEGINNING at an iron pin on the Eastern side of Broughton Drive at the joint corner of Lots Nos. 47 and 48 (as revised), and running thence along the common line of said lots and beyond along the common line of Lots Nos. 46 and 48, N. 87-54 E. 251.4 feet to iron pin; thence S. 1-47 E. 80 feet to iron pin at joint rear corner of Lots Nos. 48 and 49 of Section H (as revised); thence along line of Lots Nos. 48 and 49, S. 87-54 W. 250.5 feet to iron pin on the Eastern side of Broughton Drive; thence along the Eastern side of Broughton Drive, N. 2-06 W. 80 feet to an iron pin, the beginning corner."

Said premises being the same conveyed to J. E. Meadors by deed recorded in Book of Deeds 435 at Page 141; the said J. E. Meadors having conveyed a one-half interest to J. W. Cannon by deed recorded in Book of Deeds 436 at Page 493.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
