We, Joseph E. Davis and Lora Davis

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Seven Hundred and No/100- - - - - DOLLARS (\$5700.00), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as lot No. 3 of Love Estates, made by W. J. Riddle, in April 1938, and recorded in Plat Book at Pages 111 and 112, and described as follows:

"BEGINNING at a point on the East side of the Buncombe Road, 200 feet in a North-east direction from the Southern boundary of the Love property; and running thence S. 69-10 E. 554 feet to a branch; thence up said branch, 39 feet to a corner; thence N. 62-20 W. 531 feet to Buncombe Road; thence down said Buncombe Road, S. 29-40 W. 100 feet to the beginning."
