NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the East side of the Augusta Road, containing 6.10 acres and being known and designated as lot No. 4 of property of Dr. S. D. Campbell as shown on plat by Dalton & Neves, November 1945, and described as follows:

"BEGINNING at an iron pin on the East side of the Augusta Road, corner of property now or formerly of Dr. S. D. Campbell, and running thence with line of said property, N. 50-15 E. 434.5 feet to iron pin in an abandoned road; thence S. 66-10 E. 387.5 feet to an iron pin corner of tract 1; thence with line of said tract, S. 9-24 E. 244.4 feet to corner of tract 3; thence with line of said tract, S. 75-24 W. 700 feet to iron pin on East side of Augusta Road; thence with the East side of said Road, V. 10-0 W. 300 feet to the beginning."
