(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and No/100- - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the North side of Airport Road, formerly Woodscrossing Road, and being more particularly described as follows:

"BEGINNING at an iron pin on the North side of Airport Road, and running thence with the North side of said Road, S. 80-06 W. 168.8 feet to an iron pin, corner of lot now or formerly of Ruth B. McCauley; thence with line of said lot, N. 23-19 W. 136.8 feet to pin; thence continuing N. 10-26 W. 76.4 feet to iron pin; thence still with line of McCauley property, N. 80-06 E. 188 feet to iron pin; thence S. 13-31 E. 210 feet, more or less, to iron pin on Airport Road, the point of beginning."
