To All Whom These Presents May Concern:

I, Andy M. Todd,

SEND GREETING:

Whereas, BY the said Andy M. Todd,in and by BY certain promissory note in writing, of even date with these
Presents, am well and truly indebted to E. N. Edwardsin the full and just sum of Three Thousand Two Hundred Dollars (\$3,200.00)to be paid at the rate of Forty Dollars (\$40.00) per month for seventeen consecutive months, beginning November 1, 1951, and continuing in like monthly payments for 17 consecutive months, the balance of said indebtedness to be payable upon demand. In the event the maker is in default two months' payments, then the full balance is to immediately become due and payablewith interest thereon from dateat the rate of 7 per centum per annum, to be computed and paid at maturity

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain lot or parcel of land, situate, lying and being in the State of South Carolina, County of Greenville, better known and described as Lot No. 76 of the property known as Nicholtown Heights, No. 2, surveyed by W. J. Middle in April 1941, plat recorded in the Office of Register of Deeds conveyance for Greenville County, S. C., to which plat and record thereof reference is hereby made. This lot faces 40 feet on Milton Street; 136 feet on the North side; 38.8 feet on the East side, and 145 feet on the West.

All that certain lot or parcel of land, situate, lying and being in the State of South Carolina, County of Greenville, better known and described as Lot No. 77 in the property known as Nicholtown Heights No. 2, surveyed by W. J. Middle in April 1941, plat recorded in the Office of the Register of Deeds conveyance for Greenville County, S. C., to which plat and record thereof reference is hereby made.

The last described lot faces 40 feet on Milton Street; 136 feet on the East; 38.8 feet in the rear, bordering Lot No. 114 of this development; 127 feet on River tract.
